Portfolio Update:

- KKC fell by -0.32% over the month. Looking at underlying asset performance, part of the Fund's underperformance vs. the benchmark was driven by two holdings: Wheel Pros Inc. which detracted -25bps over the month, and Foresight Energy which detracted -15bps over the month, both in relative terms. Both assets are relatively small compared to other assets in the portfolio. We continue to monitor both names closely as we chart the best path forward for these holdings in the portfolio.
- The weighted average price of the underlying KKC assets in the portfolio stood at 97.5% of par as at month end. The Yield to Maturity, which is inversely related to prices, stood at 9.9% and the current yield of the underlying assets in the portfolio was 9.5%⁽³⁾.
- European Direct Lending (EDL) had two new additions during the month; a UK human capital management solutions provider and a UK specialist consultancy services provider. There was also one realization, a UK air freight and logistics provider. EDL represents ~46% of KKC's portfolio invested as at month end.

Distribution Update:

- KKC declared a distribution of A\$0.0167 (8.17% of NTA) for the month. This is in line with the announced FY25 distribution estimate of A\$0.20. The distribution guidance for the year ending 30 June 2025 will keep the monthly distribution target unchanged at A\$0.0167 per unit per month, or A\$0.20 per annum. As of 31 August, ASX Unit Price is A\$2.32, this represents a yield of ~8.62%⁽²⁾.

Market Update:

- High Yield bonds returned +1.59%⁽⁸⁾ in August, as yields fell amid resilient US growth data. Loans underperformed High Yield bonds for the fourth consecutive month, returning +0.63%⁽⁹⁾ in August. Loan prices were steady and yields extended their decline in August amid the largest retail withdrawals since March 2023 offset by encouraging growth sentiment, robust CLO origination, and the lightest capital market activity in a year.



KKC Overview

The Trust aims to provide investors with attractive, risk-adjusted returns and access to a diversified portfolio of income generating alternative credit investments through the Trust's investment across strategies managed by the credit investment teams of Kohlberg Kravis Roberts & Co. L.P. ("KKR").

These strategies comprise the Global Opportunistic Credit strategy and European Direct Lending strategy, which seek to take advantage of the attractive opportunities that KKR sees in the market. The Trust's investment objective is to provide an income stream as well as to achieve attractive long-term capital appreciation over a full market cycle.

KKC has announced that for the financial year ending June 2025, KKC is targeting a distribution of +8.6% based on the issue NTA per unit of A\$2.3308⁽²⁾ (20.0c per year). The Trust continues to target a medium-term average total return of 6% - 8% per annum⁽⁵⁾ through the market cycle.

The Trust is appropriate for investors seeking income distribution to be used as a satellite allocation within a portfolio where the investor has a 5+ year investment timeframe and a medium to high risk/return profile.
