## Portfolio Update:

- KKC delivered a 2.53% return in March, driven from strong security selection in lower rated credits, which resulted in outperforming the broader traded credit markets.
- The weighted average price of the underlying KKC assets in the portfolio stood at 96.0% of par as at month end. The Yield to Maturity, which is inversely related to prices, stood at 10.8% and the current yield of the underlying assets in the portfolio was 9.9%<sup>(3)</sup>.
- European Direct Lending (EDL) had no new additions over the month. There were four realizations, a French food ingredients provider, a Dutch IT services provider, a Swedish software services provider and a Dutch chemical distributor. EDL represents ~45% of KKC's portfolio invested as at month end. A case study on one of our EDL deals (which is a top 10 position for KKC) can be found on page 3.

## Distribution Update:

- KKC declared a distribution of A\$0.0167 (7.95% of NTA) for the month. This is in line with the announced FY24 distribution estimate of A\$0.20. As of 31 March, ASX Unit Price of A\$2.32, this represents a yield of ~8.62%<sup>(2)</sup>.

## Market Update:

- High Yield bonds returned +1.19%<sup>(8)</sup> in March amid a supportive earnings season, improving capital market access and dovish Fed sentiment. Loans returned +0.85%<sup>(9)</sup> in March as secondary prices reached its highest levels in almost two years. Despite the high institutional volume, pressure on loan prices remains as limited new net supply and record-high CLO volume continues.



#### Company Overview


- PIB Group (“PIB”) is a leading, diversified United Kingdom insurance brokerage business operating within retail and wholesale insurance markets.
- PIB’s retail division sells policies to businesses and individuals, with the individual brokerages highly specialized across insurance product lines. The wholesale division provides specialized insurance products and services to other retail brokers.

#### Transaction Overview

- Apax Partners (“Apax”) acquired PIB in early 2021 from Carlyle for an EV of £1.3 billion (16x Pro Forma EBITDA).
- KKR Credit has been a lender to PIB since 2019 (to support M&A). In March 2021, we provided financing for Apax’s acquisition of PIB from Carlyle (£482 million Unitranche and £150 million Delayed Draw Term Loan (“DDTL”). In December 2021, PIB then upsized this debt to increase capacity for the ongoing M&A strategy (to £632 million Unitranche and £430 million DDTL).
- More recently, in March 2023 we provided ~7.0% of a £280 million Acquisition Capex Facility DDTL upsize to support continued M&A activity.
- Given KKR Credit’s significant experience in the United Kingdom insurance broking space, our multi-year history with PIB (lenders since it was £25 million EBITDA vs ~£160 million Pro Forma EBITDA today) and close relationship with the management team and Sponsor, we were well positioned to provide the financing.
- KKR Credit’s investment thesis is based on: (i) the stable insurance market; (ii) a naturally recurring revenue model given annual renewal cycles; (iii) a highly cash generative business model; (iv) a strong management team; and (v) PIB’s strong record as a highly successful consolidator within the fragmented market.

### KKC Overview

The Trust aims to provide investors with attractive, risk-adjusted returns and access to a diversified portfolio of income generating alternative credit investments through the Trust's investment across strategies managed by the credit investment teams of Kohlberg Kravis Roberts & Co. L.P. ("KKR").

These strategies comprise the Global Opportunistic Credit strategy and European Direct Lending strategy, which seek to take advantage of the attractive opportunities that KKR sees in the market. The Trust's investment objective is to provide an income stream as well as to achieve attractive long-term capital appreciation over a full market cycle.

KKC has announced that for the financial year ending June 2024, KKC is targeting a distribution of +8.6% based on the issue NTA per unit of A\$2.3308<sup>(2)</sup> (20.0c per year). The Trust continues to target a medium-term average total return of 6% - 8% per annum<sup>(5)</sup> through the market cycle.

The Trust is appropriate for investors seeking income distribution to be used as a satellite allocation within a portfolio where the investor has a 5+ year investment timeframe and a medium to high risk/return profile. ### KKR Overview
