## KKR CREDIT INCOME FUND (ASX:KKC) SUSPENSION OF DISTRIBUTION REINVESTMENT PLAN

As previously announced on 19 April 2021, KKR Credit Income Fund (**the Fund**) will move to monthly distributions with the first being paid in August 2021 for the month of July 2021. In order to move to monthly distributions, the Manager, in consultation with the Responsible Entity of the Fund, has decided to suspend the operation of the Distribution Re-investment Plan until further notice.

With the suspension of the DRP, all KKC unit holders will receive their distributions as a cash payment, payable only via electronic funds transfer in AUD to a nominated bank account. Consequently, unitholders are encouraged to promptly ensure their payment details are up to date with KKC's registry, Boardroom Limited. Boardroom's contact details can be located below. Please also note that if you had elected to participate in the DRP, your distribution preferences will revert to DRP if the plan is re-enacted.
