## Portfolio Update:

- KKC delivered a +0.96% return in July. High Yield bonds outperformed Loans over the month and B and CCC rated assets drove performance across asset classes.
- The weighted average price of the underlying KKC assets in the portfolio stood at 96.1% of par as at month end. The Yield to Maturity, which is inversely related to prices, stood at 10.8% and the current yield of the underlying assets in the portfolio was 9.9%<sup>(3)</sup>.
- European Direct Lending (EDL) had one new addition during the month; a UK software and services provider. It had no new realizations. EDL represents ~44% of KKC's portfolio invested as at month end. A case study on one of our EDL deals can be found on page 3.

## Distribution Update:

- KKC declared a distribution of A\$0.0167 (8.09% of NTA) for the month. This is in line with the announced FY25 distribution estimate of A\$0.20. The distribution guidance for the year ending 30 June 2025 will keep the monthly distribution target unchanged at A\$0.0167 per unit per month, or A\$0.20 per annum. As of 31 July, ASX Unit Price is A\$2.35, this represents a yield of ~8.51%<sup>(2)</sup>.

## Market Update:

- High Yield bonds returned +1.96%<sup>(8)</sup> in July, as retail inflows accelerated, capital market activity slowed and broad economic data and messaging from the Fed bolstered bets for a rate cut in September. Loans posted their ninth consecutive monthly gain, returning +0.68%<sup>(9)</sup> in July. There was a much-needed increase in M&A financings in July, a positive sign for future growth.

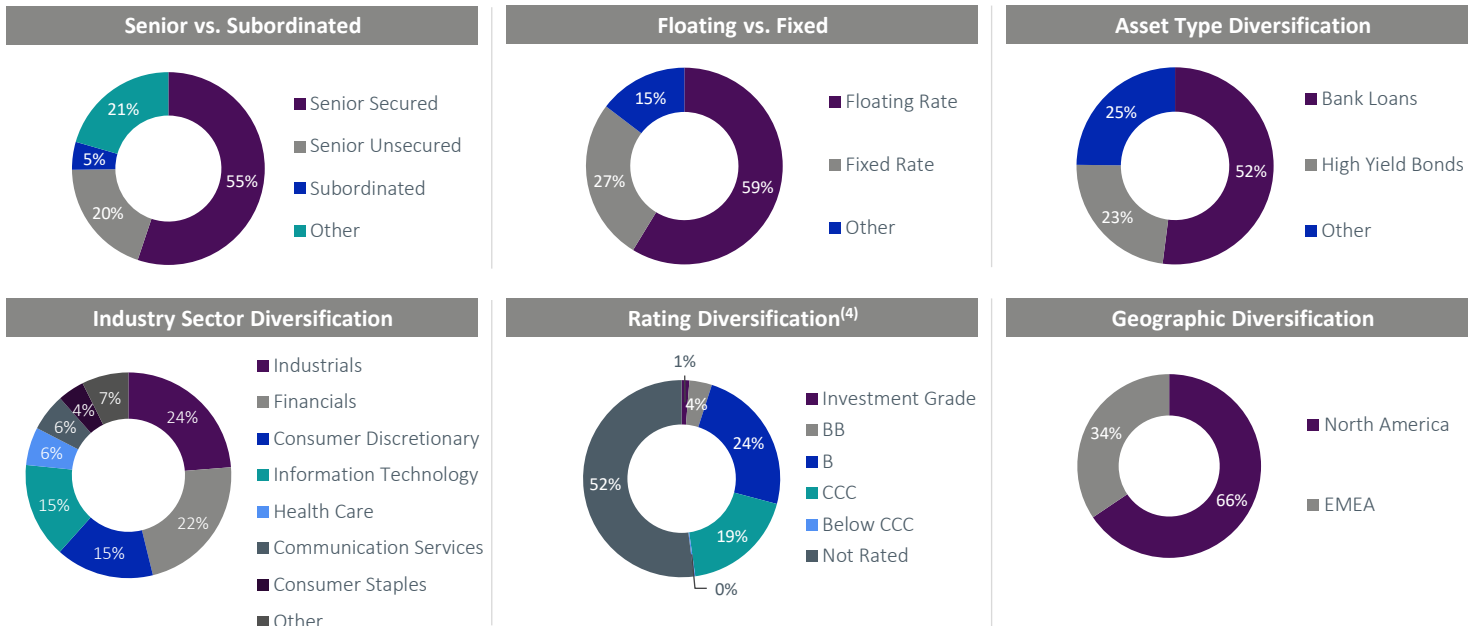

## Portfolio Case Study

### Company Overview

- CFC Underwriting Ltd ("CFC") is an international SME insurance platform with a focus on cybersecurity insurance, technology & media, and professionals.
- The company distributes policies to SME clients in the US, UK, Canada and Australia, through a network of over 2,800 broker offices.
- CFC is structured as an MGA (Managing General Agent). MGAs underwrite insurance on behalf of the carriers and thus assume no underwriting risks.
- Vitruvian initially invested in the company in 2017. In 2021, EQT acquired a ~33% ownership for a total EV of £2.5 billion (33x Structuring EBITDA), with Vitruvian and management owning the other ~66%.

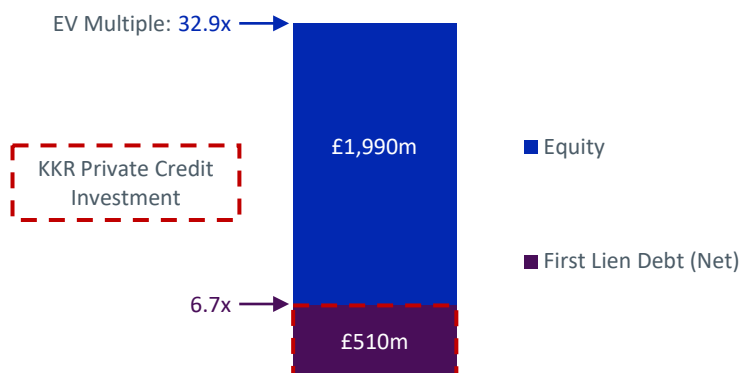


### Transaction Overview

- CFC has a very strong financial profile with strong organic revenue growth and high, stable EBITDA margins.
- The robust financial track record is supported by attractive market tailwinds (increased demand and penetration of cybersecurity insurance), unique market positioning (number one cybersecurity insurance provider in UK), and best-in-class management team.
- Leveraging our knowledge of other KKR investments in the insurance sector and using the support of KKR Capstone experience in cybersecurity, KKR Credit was able to diligence the business effectively to provide financing to the sponsor in a timely manner.

### KKC Overview

The Trust aims to provide investors with attractive, risk-adjusted returns and access to a diversified portfolio of income generating alternative credit investments through the Trust's investment across strategies managed by the credit investment teams of Kohlberg Kravis Roberts & Co. L.P. ("KKR").

These strategies comprise the Global Opportunistic Credit strategy and European Direct Lending strategy, which seek to take advantage of the attractive opportunities that KKR sees in the market. The Trust's investment objective is to provide an income stream as well as to achieve attractive long-term capital appreciation over a full market cycle.

KKC has announced that for the financial year ending June 2025, KKC is targeting a distribution of +8.6% based on the issue NTA per unit of A\$2.3308<sup>(2)</sup> (20.0c per year). The Trust continues to target a medium-term average total return of 6% - 8% per annum<sup>(5)</sup> through the market cycle.

The Trust is appropriate for investors seeking income distribution to be used as a satellite allocation within a portfolio where the investor has a 5+ year investment timeframe and a medium to high risk/return profile. ### KKR Overview
