MONTHLY UPDATE

For the month of July 2022, the KKR Credit Income Fund ("KKC" or the "Trust") recorded a total net return of +2.65%².

KKC declared a distribution of A\$0.011 (0.49% of NTA) for the month. KKC expects investors to receive A\$0.011 per month for the current financial year². This is in line with the announced FY23 distribution estimate of A\$0.13125 or 5.25% (based on Issue Price). As of the 31^{st} July NTA of A\$2.27, this represents a yield of ~5.79%.

High yield bonds posted their strongest return since October 2011 in July, following the second worst performance post-Global Financial Crisis in June. Specifically, high yield bonds were up +5.80% in July⁽³⁾ amid better-than-expected earnings, negligible supply, and large retail inflows. Meanwhile, loans provided a +1.93% return. By comparison, 10-year Treasuries, high-grade bonds, and emerging market bonds returned +3.11%, +2.81% and +3.20%.


The weighted average price of the underlying assets in the portfolio stood at 90.3% of par as at month end. The Yield to Maturity, which is inversely related to prices, stood at 11.0% as at month end⁴. The current yield of the underlying assets in the portfolio was 8.1% as at month end⁴.

Key portfolio positioning and changes in the underlying portfolio from 30 June 2022 and 31 July 2022⁵ are as follows:

 Defaulted assets continue to be absent for KKC with 0% of the portfolio (% based upon Market Value) rated as "D" by Rating Agencies⁶;

- The proportion of floating rate assets in the fund is at 66%, the majority of which are loans. Loan coupons are generally based on 3-month LIBOR plus a fixed credit spread. Because the interest rate component of the coupon resets quarterly, loans have a low interest rate duration of approximately 0.25 years. Loans and other floating rate assets can act as a natural hedge against inflation and rising interest rates. The portfolio is still intentionally overweight floating rate assets and has a low duration of 1.4 years compared to ~4 years for the bond market as a whole;
- Consumer Discretionary and Industrials remain the two largest sectors at about 24% and 23% respectively. The fund is also deliberately underweight Energy with only 1% of the portfolio invested in this sector;
- KKC's exposure to senior assets currently stands at ~90%.
 Senior assets in the issuer's capital structure afford greater downside protection for our investors, relative to junior assets.

European Direct Lending (EDL) had four new additions during the month; a Swedish freight & logistics company, an Irish IT consulting company, a German digital marketing company and a US testing business focusing on aerospace and automotive. There were no realisations over the month. EDL was ~66% net deployed (on a Cost basis) across 33 privately originated assets as at month end.






FLOATING vs. FIXED




■% Floating Rate

KKC OVERVIEW

The Trust aims to provide investors with attractive, risk-adjusted returns and access to a diversified portfolio of income generating alternative credit investments through the Trust's investment across strategies managed by the credit investment teams of Kohlberg Kravis Roberts & Co. L.P. ("KKR").

These strategies comprise the Global Opportunistic Credit strategy and European Direct Lending strategy, which seek to take advantage of the attractive opportunities that KKR sees in the market. The Trust's investment objective is to provide an income stream as well as to achieve attractive long-term capital appreciation over a full market cycle.

The Trust seeks to deliver investors with a distribution yield of 4% - 6% per annum⁽²⁾, paid monthly in arrears. KKC has announced that for the financial year ended June 2023, KKC is targeting a distribution of +5.25% based on the issue NTA per unit of A2.50^2$ (13.125c per year). The Trust continues to target a medium-term average total return of 6% - 8% per annum⁽⁷⁾.

KKR OVERVIEW

Established in 1976, KKR is a global investment firm with industry-leading investment experience, a pioneering attitude to ESG management and a strong culture committed to teamwork.

As of 30 June 2022, KKR had A\$713.3 billion of assets under management, of which A\$259.3 billion sits within KKR Credit. (8)
