## **Portfolio Update:**

- KKC delivered a +1.26% return in May. High Yield bonds outperformed Loans over the month and B and CCC rated assets drove performance across asset classes.
- The weighted average price of the underlying KKC assets in the portfolio stood at 98.7% of par as at month end. The Yield to Maturity, which is inversely related to prices, stood at 9.1% and the current yield of the underlying assets in the portfolio was 8.4%<sup>(3)</sup>.
- European Direct Lending (EDL) had one new addition during the month, a UK leisure facilities provider. There were no realisations. EDL represents ~42% of KKC's portfolio invested as at month end. A case study on one of our EDL deals can be found on page 3.

# Distribution Update<sup>(2)</sup>:

KKC declared a monthly distribution of A\$0.0167 which equates to an annualised distribution rate of 8.24% of the 31 May 2025 NTA. This is in line with the announced FY25 distribution estimate of A\$0.20. As of 31 May 2025, the ASX Unit Price is A\$2.27, this represents a yield of 8.83%. The distribution guidance for the financial year ending 30 June 2026 will be updated shortly.

### Market Update:

The US credit market posted a strong comeback in May as prices rebounded and risk appetite resumed, supported by easing trade tensions, resetting of Fed expectations, and improving consumer sentiment. High Yield bonds rallied in May, returning +1.68%<sup>(8)</sup>. The Loan market recorded its best monthly return in 17 months, rising +1.55%<sup>(9)</sup> in May amid supportive capital market activity, steady retail inflows, and heavy CLO origination.



# **Portfolio Case Study**

## **Company Overview**


- Grant Thornton UK ("GT UK") is a diversified professional services firm, providing Audit, Tax and Advisory services mainly to mid-market clients in the United Kingdom.
- GT UK operates across three business lines: Audit (34% of revenues), providing audits and financial reporting advice; Advisory (51%), providing deal advisory, business consulting, and forensic and restructuring services; as well as Tax (15%), providing compliance services and tax advisory.

### **Transaction Overview**

- In November 2024, Cinven acquired a majority stake in Grant Thornton UK from the GT UK Partners at an Enterprise Value of ~£1.5 billion, or a ~14x EV/ EBITDA multiple.
- KKR Credit provided £162 million of the £500 million Unitranche Term Loan used to finance the acquisition.
- Our investment thesis is predicated on GT UK's: (i) strong market positioning (#2 player) and high brand recognition among mid sized companies in the UK; (ii) highly diversified revenue streams with a large customer base and a strong mix across a-cyclical (audit, tax), counter-cyclical (forensic and restructuring advice) and cyclical (deal advisory) business lines; (iii) a strong financial profile with ~80% of sales being recurring / re-occurring, coupled with high cash conversion; and (iv) a growing underlying market underpinned by structural tailwinds such as increasing regulation and complexity.
- KKR Credit's core focus through the underwrite was ensuring the strong
  alignment of interests between the Grant Thorton UK Partners, the
  Sponsor and the Lenders. We were able to gain conviction on this point
  given the GT UK Partners will remain strongly incentivized in the new
  deal given: (i) they have retained a substantial minority equity stake;
  and (ii) ~25% of their cash proceeds from the sale will be reinvested in
  the business.

### **KKC Overview**

The Trust aims to provide investors with attractive, risk-adjusted returns and access to a diversified portfolio of income generating alternative credit investments through the Trust's investment across strategies managed by the credit investment teams of Kohlberg Kravis Roberts & Co. L.P. ("KKR").

These strategies comprise the Global Opportunistic Credit strategy and European Direct Lending strategy, which seek to take advantage of the attractive opportunities that KKR sees in the market. The Trust's investment objective is to provide an income stream as well as to achieve attractive long-term capital appreciation over a full market cycle.

KKC has announced that for the financial year ending June 2025, KKC is targeting a distribution of A\$0.0167 per month or A\$0.20 per annum<sup>(2)</sup>. At the current NTA of \$A2.43 per unit, that represents an annual distribution yield of 8.24%<sup>(2)</sup>. The Trust continues to target a medium-term average total return of 6% - 8% per annum<sup>(5)</sup> through business cycles.

The Trust is appropriate for investors seeking income distribution to be used as a satellite allocation within a portfolio where the investor has a 5+ year investment timeframe and a medium to high risk/return profile.
